Students who receive special education supports and services are entitled to an education program that meets their unique needs.

Communication while creating this program can be challenging and those involved may disagree on the appropriate way to support a student. That's when Special Education Mediation Services (SEMS) can help.

Whether to resolve a disagreement about the program or to provide collaborative process support, teams — and ultimately students — benefit from the skills and experience of a mediator or facilitator.

Resolve disagreements
